Candidate filing for the November 3, 2020 General Election will begin on Monday, June 8, 2020 at 12:00 p.m. through Monday, July 6, 2020 at 12:00 p.m. Filing will occur at the office of the Durham County Board of Elections located at 201 N. Roxboro Street, Durham, NC 27701. Excluding the first and last day of filing, candidates may file at the Board of Elections during regular business hours (8:30 a.m. - 5:00 p.m.).

The deadline to withdrawal your notice of candidacy is Tuesday, June 30, 2020 at 5:00 pm.

The filing fee must be paid by check or money order, unless the fee is \$50 or less in which case it may be paid in cash (Noted in the chart on the second page of this document). All checks and money orders must be made out to 'Durham County Government'.

REQUIREMENTS

FILING PROCESS



Candidates are required to submit campaign finance paperwork within 10 days of either filing for office or making a public declaration of intent or receiving contributions, or making expenditures towards a campaign.
