# 5. Appointment for Replacement of Sheriff

Durham County Sheriff Worth Hill has submitted his resignation effective January 1, 2012, which letter of resignation is attached. Pursuant to N.C.G.S. 162-3, the Board of County Commissioners has the statutory authority to replace the Sheriff upon his resignation.

<u>County Manager's Recommendation</u>: The County Manager recommends that the Board take the necessary action to elect a successor sheriff to be effective January 1, 2012.

#### 6. Report from the ½ cent Sales and Use Tax for Public Transportation Committee

An advisory referendum on a ½ cent Sales and Use Tax for Public Transportation is scheduled for November 8. If approved, the proceeds will be used to add an extra 25,000 bus hours in the first full year of implementation. In addition, revenues will be used for commuter rail to be constructed which will run from Durham through Research Triangle Park to eastern Wake County. Finally, light rail will be constructed to eventually run from just east of downtown Durham to UNC Hospitals.

A committee of business and community leaders has been working to develop information and marketing strategies for the vote. Co-Chairs of this comprehensive effort are Dr. F. Vincent Allison, III and Ms. Susan Ross. They will provide the Board with a progress report on the group's efforts to date.

# 7. Report from the 1/4 cent Sales and Use Tax for Education Committee

15 min.

An advisory referendum on a 1/4 cent Sales and Use Tax for Education is scheduled for November 8. If approved, the proceeds will be used to help Durham Public Schools maintain jobs for approximately 151 teachers and school based personnel and to pay debt service on recently built schools. Durham Technical Community College will receive funds to award Durham Challenge Funds to Durham Public Schools' graduates and to Durham residents who are in need of training or retraining. Based on need, Challenge Funds will help Durham residents by awarding Service Stipends for campus based work study opportunities and direct grants. Durham's Partnership for Children will receive funds to support Transition to Kindergarten, a partnership program with Durham Public Schools which builds a seamless transition for young children as they prepare to enter kindergarten.

A committee of business and community leaders has been working to develop information and marketing strategies for the vote. Co-Chairs of this comprehensive effort are Mr. Steve Toler and Ms. Meredythe Holmes. They will provide the Board with a progress report on the group's efforts to date.
